5. Old Business

Discussion of Crowflight proposal re: spawning areas on Setting Lake (timed item for before Committee Reports)

Don McDonald of Provincial Fisheries shared the following information. Most of this involves Environment Canada primarily and Federal Fisheries. Bucko Lake is a good solution for tailings. Bucko is considered fish habitat. It would have to be de-laked. Crowflight needs 318 hectares of fish habitat to replace Bucko. Nothing spawns on Setting Lake because of monolithic rock unlike Paint Lake which is spawning habitat. Suggestion to create artificial spawning grounds on Setting Lake. Hoping to diversify spawning opportunities. Grey fishing and commercial fishing are creating a problem. Can't do much about subsistence fishing. Environment Canada is afraid of licencing. There are limitations on where rock is placed. They are talking predominantly shores of islands and some shoreline with wave action. Studies have been done. Straight off the Wabowden boat launch is the greatest area. Most of the islands around Roads 2 and 3 are not appropriate. The north-east sector of the lake is appropriate. Crowflight's opinion is giving Setting Lake additional spawning habitat is worth more than the loss of Bucko. They will be asking SLCOA for input on appropriate sites, acceptability of proposal, etc. Provincial Fisheries is test netting Setting Lake permanently (second year of program) which monitors and there is a Manitoba Hydro gauge station at the outlet of Setting (a normal monitoring program).

The SLCOA executive will continue to arrange a meeting with Crowflight officials to discuss the proposal.

AEDs Pending the Crowflight meeting, a call will be arranged with the Calgary company.
