Roads Roads were graveled last year. Roads were plowed three times this winter plus spring clean up of slush and ice. Third road culvert will be repaired as soon as the thaw is complete. Gravel is needed on the entrance to the metal pile at the dump. Last year's gravelling of the dump road has improved the road overall. Roads will be inspected for maintenance issues once the spring thaw is complete.

Dump The metal pile was removed late in the fall. The dump is looking good. It burned last Sunday most likely from hot ashes being dumped. It will be pushed again after the spring cleanup which is scheduled for May 28 at 10:00 a.m. followed by lunch at the Fire Hall. Joe Roque will arrange the lunch and Don Wensley will look after materials for the cleanup. The lagoon will be equalized once the ice goes off. A sample will be done later in the summer. Everything at the lagoon looks good. Grass cutting is scheduled for July 13 at 10:00 a.m. Don will talk to Ernie Trach about dragging metal out of the dump.

Fire No fires were reported during the winter season. Spring equipment maintenance will take place as soon as the spring thaw is complete. The AED issue will be discussed at the AGM. Al Kozakowski has talked to nurse Heather Thackery who is willing to offer CPR training at Setting Lake. An invitation will be extended to Heather to speak at the AGM. The Provincial government has launched an initiative to put AEDs in all public places. The executive will follow up on potential grants.
