Roads Al reported that an inspection of all roads will take place this afternoon. Off take on Road 3 culvert needs cleaning out and the bend by Nychuk's driveway needs gravel. Fire Equipment needs were discussed. A quote has been received for new pumps to replace some of our older pumps. It was suggested that we approach Natural Resources about obtaining some of their older pumps. Doug will follow up. It was decided that quotes be obtained for a gas powered ice auger for the trailer. Hugh will contact Ian about plans for winterizing the equipment. The fire list needs to be updated.

- Crowflight proposal re: spawning areas on Setting Lake Hugh spoke to the Crowflight rep who indicated that the company is waiting to hear from Oceans and Fisheries. He said the Province would place the rock on the ice in the winter but Crowflight has expressed concern about the safety issues involved for snowmobilers, etc. He will keep our association informed about any progress with the proposal.
- AEDs. Suggestion that first aid equipment including back boards be investigated and costed. Al has volunteered to do this. A call will be arranged with the Alberta rep. re: AEDs for September's meeting. A list of first aid equipment will be made in consultation with medical personnel and costed. The call to the AED rep will happen in October.
- Fire Billing for Spring 2009 Fire. No response has been received to our letter from Wabowden Council.
- The Cottager magazine distribution. A cheque in the amount of seventy (\$70.00) dollars has been received from The Cottager magazine for distributing their summer issue. Hugh has received permission to place on our website the article on Setting Lake.
- Insurance coverage for executive members. Officers and Directors liability insurance which protects the executive members if the Association is sued is being researched. Doug recommends that Kevin obtain information and quotes on appropriate coverage. We also need clarification as to WCB coverage of exec members like Don burning the dump.
