#### **Executive Highlights**

The executive met with Don McDonald of Provincial Fisheries to discuss a proposal from Crowflight Minerals regarding spawning habitat. Bucko Lake is a good solution for tailings but is considered fish habitat. Crowflight needs 318 hectares of fish habitat to replace Bucko. The suggestion is to create artificial spawning grounds on Setting Lake. There are limitations on where rock is placed. They are talking predominantly shores of islands and some shoreline with wave action. Studies have been done. Crowflight will be asking the SLCOA for input on appropriate

sites, acceptability of the proposal, etc. I have spoken to a Crowflight rep who indicated that the company is waiting to hear from Oceans and Fisheries. He said the Province would place the rock on the ice in the winter but Crowflight has expressed concern about the safety issues involved for snowmobilers, etc. He will keep our association informed about any progress with the proposal.

The executive is working on implementing AEDs (automated external defibrillators) at Setting Lake. I spoke with Thompson Fire Department Deputy Chief Kane Doran who recommended Medtronic for AEDs. He indicated the matter. that AEDs are fully deregulated in Manitoba now so no one can be held liable for using one. He said Paint Lake is implementing them. The other equipment he recommended is first aid kits stocked with splints and bandages. He advised against backboards as they are regulated and a person requires



#### **Fire Report**

All fire barrels have been inspected and prepared for winter. Barrels have been checked for contents, and most are properly stocked. Two have missing floats but I will replace them, and one has a missing hose nozzle, and I also will ensure that gets replaced. Barrel Pumps were also inspected, and all seem to be in good shape, free of gas in carburetors, and water in the pumps. All but one looks unused this year. Trouble finding the

road four barrel as it was moved down to the lake. Pumps in the fire trailer were also inspected, to ensure no water remained in pumps, and fuel was drained from carbs. Fogging oil was also added to the pistons for winter storage. The back pack pumps have also been drained for the winter, and will be refilled in the spring. Fire trailer seems to be in good shape and ready to go.

**Resources** If there is a bush fire NOT on cottage property Resources must be called. Also call the Setting Lake Fire Department. DO NOT call the Wabowden Fire Department.

**Setting Lake FD** If the fire is on property between a cottage and the road call the Setting Lake Fire Department.

Wabowden FD If there is a cottage fire call the Wabowden Fire Department. There is a charge each time they are called out, so ensure your insurance covers fire services. More importantly it is taking them far away from the community for emergencies there, so do not call them unnecessarily. Also call the Setting Lake Fire Department.

When you call give your road number and lot number. They have the list of cottages.
