Roads All the gravelling has been done and extra loads were applied to roads 2 and 4 as per last meeting. After consultations with the contractors we will not require to extend the culvert on road 2 as first thought. We will not be cutting the brush

on the roads this fall and will reassess next year. We have spent a lot of money on the roads this year and it is a shame that people are abusing and destroying some of the work that we had done. Work is being done on Road 4 now that the hydro pole has been moved. The corner will be widened and a culvert installed.

Dump/Lagoon The dump needs pushing again. The lagoon will be mowed and the steel pile straightened when the dump is done.

Fire The pump on Road 3 has been moved to a more central location at Lot 34 from Lot 23. We are looking at high visibility signage for all road pumps. Personal protection has been added to the fire trailer (box containing first aid-PPE). We have a problem with mice in the fire hall chewing hose. We are looking at acquiring electronic devices.
